Minor Modification of CUP PL13- 0112 to authorize the continued operation of an existing WCF for a 10-year period. The existing WCF is designed as a 50-foot stealth faux palm tree with 800 square-foot-fenced accessory equipment enclosure.

The WCF is unmanned, except for occasional periodic maintenance visits, and would continue to operate 24 hours per day. The WCF does not require water to operate.
