REASONS WHY ACTIVITY/PROJECT IS EXEMPT: The proposed action would demolish the incinerator stack. As confirmed in the report of a dangerous building, the stack is unstable and in imminent danger of collapse, and collapse could result in widespread damage and threats to personal safety. The action responds to an emergency and is exempt from CEQA review. CEQA Guidelines section 15269(c). No CEQA review is required.
