This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 83865). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The proposed project consists of a subdivision of approximately 7.5 acres into 29 lots with 28 lots for single-family residences and with one lot for a detention basin. The lots range in size from 6,712 square feet to 12,309 square feet. Access into the subdivision would be provided from 33rd Street West. All the streets within the development would be public.

Location: The project site is located near the southwest corner of Avenue J and 32nd Street West in the City of Lancaster (Assessor Parcel Numbers [APNs] 3153-017-022, -023 and -024).

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, and noise.
