Project Title: Grandy Stream Crossings Replacement Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-48055-R1C)

Project Location: The Project is located within the Price Creek watershed, approximately 6 ½ miles west of the City of Rio Dell, County of Humboldt, State of California. The Project is located in Section 31, T2N, R1W, Humboldt Base and Meridian; in the Fortuna U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 106-161-013.

Project Description: The Project is limited to two encroachments to upgrade existing stream crossings. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized rock and culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Crossing-1 shall be replaced with a minimum 42-inch diameter culvert, installed to grade (or as near as possible). The fill prism shall consist mainly of clean quarry rock and provide a critical dip. Crossing-2 shall be replaced with a vented ford design, consisting of a new 36-inch diameter culvert. The road prism shall be excavated down to natural grade to create a minimum chute width of six feet. Riprap shall consist of D50 2.25-feet at a minimum depth of 4.5-feet.
