The City of Rancho Cordova (City) proposes to construct a new bicycle and pedestrian overcrossing over U.S. Route 50 (US 50), along with approximately 3,200 feet of Class 1 bicycle and pedestrian improvements connecting Folsom Boulevard with White Rock Road (proposed project).
