NORTH INTERCEPTOR EMERYVILLE REHABILITATION
(SD-454)

Overview and Background

The East Bay Municipal Utility District's (EBMUD) North Interceptor conveys sewerage from the cities of Albany, Berkeley, El Cerrito, Emeryville, Kensington, and the Richmond Annex to the Main Wastewater Treatment Plant (MWWTP) for treatment of wastewater to protect environmental health and comply with regulations. The North Interceptor Emeryville Rehabilitation Project (Project) addresses life and workplace safety and process reliability to minimize risk to workers, the public, and the environment.

Project Purpose and Objectives

This project will perform work on a section of the EBMUD North Interceptor sewer pipe and associated manholes in Emeryville. This project will rehabilitate or modify existing infrastructure to improve existing system processes, improve safety, and maintain treatment capacity.

Project Location

The Project is located along the shoulder of Hwy I-80E between 64th Street and Powell Street in Emeryville. All work will be completed on existing EBMUD North Interceptor infrastructure. Refer to Figure 1 for the project location.

Project Characteristics

The scope of work includes the following improvements:

1. Major civil work includes sliplining 2500 linear feet of the existing 66" reinforced concrete sewer pipe with a 60" fiberglass reinforced pipe, installation of temporary buried piping and tanks, working around and protection or relocation of existing buried utilities, manhole rehabilitation and connections, excavation of sliplining insertion pits and site restoration for paving.
2. Major structural work includes concrete manhole modifications to repair structural integrity, shoring of sliplining insertion pits, tension test for anchors and dowels in existing concrete, installation of pipe and equipment supports and pads.

Permits and Approvals

Encroachment Permits will be obtained from Caltrans, the City of Berkeley, and the City of Emeryville. The Project scope of work is limited to repair, replacement, and/or minor alteration to existing wastewater sewer pipe infrastructure.

Public Considerations

The Project segment of the North Interceptor pipe is within Caltrans property and adjacent to public access routes in the City of Emeryville within 30 feet of residential or commercial areas.

Schedule and Work Hours

Construction is scheduled to begin in August 2024. The estimated construction duration is approximately 12 months. Regular construction work hours will be 7:00 a.m. to 7:00 p.m., Monday through Friday.
