Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Distributor license submitted on 03/04/2019 by Higher Vision Distribution and a commercial cannabis Retailer license submitted on 11/07/2018 by Higher Vision Dispensary Inc.

Project Activities:

The Project will consist of cannabis distribution and retail operations at 1251 Montalvo Way, Palm Springs, CA 92262 (APN 677-451-003). Activities will occur inside two 2000 sq. ft. units (F & G) within an existing 29,950 sq. ft. building. The project site will be served by public utilities including power, water, and waste.

The Project involves the use of an existing building with no proposal for expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned for light industrial.
