Statutory Authority: California Health and Safety Code, Chapter 6.5

Project Description: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations (CCR), Title 22, Division 4.5, Chapter 20, Sec. 66270.61, has issued an Emergency Permit to the Exelixis Inc., (EPA ID# CAR000282103) to treat hazardous wastes through a controlled reaction with chemical solutions. Specifically, two (2) 1-liter and thirty-seven (37) 100-milliliter containers of Tetrahydrofuran (THF), one (1) 1-liter container of 1,4 Dioxane, one (1) 500-milliliter container of Tert-butyl methyl ether, five (5) 25-milliliter containers of Acrolein diethyl acetal, one (1) 100-milliliter container of 2-butanol, and one (1) 5-gram container of Phenethyl alcohol must be stabilized prior to transport to an authorized hazardous waste treatment, storage, and disposal facility.

These chemicals are currently being stored at Exelixis Inc. located at 1701 Harbor Bay Parkway, Alameda, California. DTSC has determined as a safety precaution to prevent an accident or severe injury, an Emergency Permit should be issued to chemically stabilize the hazardous wastes prior to storage and eventual transportation off-site by Triumvirate Environmental Services (Triumvirate).

Background: The containers have peroxide formation present on either the inside, outside, or the bottom of the chemicals' containers, as well as the thread container caps. The presence of peroxide formation may be unstable at relatively low concentrations, resulting in fire and/or explosion if improperly handled. DTSC considers these chemicals to be an imminent and substantial

endangerment to human health and the environment. Chemical stabilization is recommended prior to transport to a permitted treatment, storage, and disposal facility.

Project Activities: The treatment of these hazardous wastes involves the addition of solutions to the containers in a controlled manner to reduce the reactive or ignitable characteristics of the chemicals. Treatment will take place within a designated exclusion zone. Only technicians from Triumvirate will be allowed in the exclusion zone. Movement, preparation, and treatment of the containers will be in accordance with established standards.

Within 10 business days of the expiration of this permit, Exelixis will submit a final report, signed in accordance with Title 22, CCR Sec. 66270.11(d). The report shall include certification that the treatment area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been properly managed. The Emergency Permit is effective beginning April 29, 2024 and shall expire on June 29, 2024.
