PROJECT DESCRIPTION: The project will rehabilitate approximately 140 streets and pieces of trails within the City of Santa Clarita with a slurry seal or an overlay. Rehabilitation work includes repairs to subgrade, asphalt grinding, paving with hot rubberized asphalt, adjusting utilities, traffic markings, traffic signal detectors, and other minor activities in support of the project.

Review of the project by the Department of Public Works found that the project is exempt from the provisions of the California Environmental Quality Act.

EXEMPT STATUS: Categorical Exemption: 14 CCR Section 15301, the project is exempt under a Class 1 exemption which includes repairs and maintenance to existing highways and streets, bicycle and pedestrian trails. None of the conditions described in 14 CCR Section 15300.2 apply.

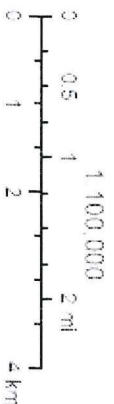
