Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 9/15/2023, by David Nicoletti. The Kuda Bros Distro, LLC applied for a Microbusiness License in an existing facility.

Project Activities:

The Project will occupy a total square footage of approximately 3,140 square feet. There are no exterior changes proposed for the building. The Microbusiness will conduct distribution, retail, and manufacturing cannabis activities. The manufacturing activities consist of non-volatile extractions utilizing water as the extraction solvent and packaging and labeling.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
