The applicant is seeking approval of a Tentative Tract Map (TTM 38468) to subdivide two parcels into 153 single-family lots. The subdivision will allow for the ultimate development of 153 single-family residences, with the minimum lot size of 6,844 square feet, an average lot size of approximately 8,123 SF, with the largest lot at 13,335 SF. # **Project Description:**

The Project proposes to subdivide two parcels via a Tentative Tract Map into 153 single-family lots that will result in the ultimate development of 153 single-family detached residences, onsite roadways, and detention basin. The residential lots would be a minimum of 6,844 square feet. The ultimate development includes 153 single-family residences on 42.19-gross acres, which would result in 3.65 units per net acre. Residential structures would be 1 or 2 stories in height.

## **Project Location:**

The 42.19-gross acre Project site is located west of Lyon Avenue approximately 137 feet north of Cottonwood Avenue in the City of San Jacinto. The Project site has a City of San Jacinto General Plan Land Use designation of Low Density Residential (LDR) and a zoning designation of Residential, Low Density (RL). The Project site is located in Section 28 of Township 4 South, Range 1 West, Lakeview United States Geological Survey (USGS) 7.5-Minute Quadrangle and is comprised of Tax Assessor Parcel Numbers (APNs) 436-280-006 and 436-280-007. The Project site is bound by residential uses on the west and south. To the north of the project site is a vacant lot and to the east a middle school.

In accordance with the disclosure requirements of CEQA Guidelines Section 15072, the Project site:
