PROJECT TITLE: Camp Cooper and Camp Sequoia Environmental Education Camps

PROJECT APPLICANT: City of Eureka Community Services – Recreation Division

PROJECT LOCATION: Cooper Gulch Park, 1720 10th Street, Eureka, CA 95501 and Sequoia Park, 3414 W Street, Eureka CA 95501

PROJECT DESCRIPTION: Camp Cooper and Camp Sequoia Environmental Education Camps (Camp Cooper and Camp Sequoia) are free outdoor environmental education camps for disadvantaged youth ages 5-12 that operate Monday through Friday, 8 a.m. to 5 p.m. throughout the summer. The Camp Cooper program has a capacity to have up to 40 campers and the Camp Sequoia program has capacity to have up to 60 campers. The two camps will have a total of 18 staff members. Camp Cooper is located at City-owned Cooper Gulch Park and Camp Sequoia is located at City-owned Sequoia Park; both parks are managed by the City's Community Services Recreation Division. Cooper Gulch Park contains a 33-acre urban forest with sports fields, walking trails and Cooper Creek, a tributary to Humboldt Bay. Sequoia Park is a 60-acre public facility that features walking trails and bicycle trails, redwood forest, meadows, a duck pond and two small creeks. Camp Cooper and Camp Sequoia emphasize environmental education experiences and engagement opportunities for youth to learn and participate in stewardship, wildlife habitat restoration, conservation and interpretation at both of the parks. Activities and experiences provided at the camps include bird watching, invertebrate discovery, introduction to tracking, scatology (scat studies), mini-water cycle observation, dam building, and a salmon spawn obstacle course. The City has successfully implemented the camp for eight summers from 2015 to 2023. The City has requested grant funding from the California State Parks' Habitat Conservation Fund Grant Program – Wildlife Area Activities to continue to offer the camp free

of charge for all participants from 2024 through 2029, including free lunches.

EXEMPTION FINDINGS: The City of Eureka as Lead Agency has determined that the above described activity is subject to the California Environmental Quality Act (CEQA). The Lead Agency has further determined that the project is exempt from CEQA pursuant to a Class I categorical exemption (Section 15301), which exempts the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use. The proposed project qualifies for the Class I exemption because it involves operating and managing an existing program at two existing public facilities (City-owned Cooper Gulch and Sequoia Park). No physical changes to each park are proposed to accommodate the summer camp, and the use (daytime supervised youth recreation) is typical for these park facilities. Further, the Lead Agency has determined that use of the categorical exemption is not barred by one of the exceptions set forth in Section 15300.2 of the CEQA Guidelines.
