

Project Title: West Sequoia Avenue Multimodal Improvements

Project Location: The proposed project site is located within the City of Dinuba. The project would affect approximately 8.18 acres within existing and future City ROW and temporary construction easement areas along West Sequoia Avenue. West Sequoia Avenue is designated as a collector street in the City of Woodlake General Plan.

Project Description: The Project seeks to enhance safety and accessibility along West Sequoia Avenue in Woodlake by developing a 0.79-mile active transportation network. This will include a 0.49-mile stretch of ADA-compliant pedestrian and bicycle facilities, featuring 15 crosswalks, 21 streetlights, a Class IV bikeway, and extensive signage. Beginning west of West Sequoia Avenue and Valencia Boulevard to Mulberry Street, the plan also entails slight extensions into adjacent north/south streets. Necessary ROW acquisitions will support minor property encroachments. Construction will involve demolishing and rebuilding sections of the road, installing an irrigation system, relocating utility poles, and managing traffic with detours or lane closures.
