Caltrans proposes a Minor B Project to perform ramp rehabilitation at the Eastbound La Jolla Village Dr. Entrance Ramp to southbound I-5 in San Diego, CA. Project work will include cold planing the top 0.2 feet of the existing asphalt concrete (AC) and replacing the AC with 0.2 feet of rubberized hot mix asphalt along the entire width of the on-ramp. All work will occur on the paved travel way within Caltrans Right-of-Way. Environmental Commitments are contained in the ECR.
