NOTICE OF EXEMPTION

Project Title: Mountain View Road Corrective Maintenance

Project Location: Mountain View Road, CR 510, Milepost 0.00 – 24.58

Description of Nature, Purpose, and Beneficiaries of Project:

This project proposes to rehabilitate/repair the road surface condition of Mountain View Rd. The existing road condition has deteriorated requiring repairs to the road base and surface. The project will improve the pavement condition and lifespan of the road.

Mountain View Rd. will be rehabilitated with full depth reclamation at multiple sections along the length of the road. The road will be resurfaced with a double chip seal. Some roadway segments will be resurfaced with an asphalt overlay to ensure a resilient restoration, including sections with sharp turns and steep grades. The project will take place within the existing road Right-of-Way. The newly resurfaced road will receive new traffic striping and pavement markings. Rehabilitation of the road surface will enhance the safety of the traveling public. No trees will be removed and disturbance to vegetation will be minimal. Mountain View Road will remain open with traffic control at each work location during construction. The project will not impact sensitive cultural or biological resources. The work is anticipated to begin and be completed during summer 2024.

Beneficiaries of the project are the traveling public.


