Project Description (Proposed actions, location, and/or consequences).

The proposed project involves the development of a 86- lot single family residential subdivision at the southeast corner of Foster Drive and Mooney Boulevard. The project includes a zone amendment, which is a request to change the existing zoning designation from R-1-6 (Single-family Residential, 6,000 sq. ft. minimum lot area) to the R-1-5 (Single-family Residential, 5,000 sq. ft. minimum lot area) zone. The project also includes a 17,133 square foot park (0.39 acre). The proposed project would result in on-site infrastructure improvements, including extending segments of Mooney Boulevard and Foster Drive, as well as new city streets within the subdivision. Construction is proposed to begin in October 2024 and continue for 24-36 months.

Potentially significant impact to biological resources mitigated with implementation of Mitigation Measures Bio - 1a, 1b, 1c, 2a, 2b, 2c, 3a, 3b, 3c requiring pre-construction surveys for nesting raptors and migratory birds, Swainson's hawk, burrowing owl and kit for. establishes requirements and procedures in the event that nests or species are identified on site during the required pre-construction survey or during construction to avoid and minimize potential impact from the project. Potentially significant impact to cultural resources mitigated with implementation of Mitigation Measures CUL-1 and CUL-2 requires ground disturbance activities to cease if cultural resources or human remains are encountered and consultation with an archaeologist or contacting the County Coroner and NAHC if determined to be prehistoric. requiring stopping work and contacting a qualified archaeologist, County Coroner, or Native American Heritage Commission, as required. Potentially significant impact to transportation resources mitigated with implementation of Mitigation Measures Trans -1, 2, 3, 4, 5 requiring development of a bus stop in conjunction with the subdivision, payment of local street and traffic signal impact fees, pavement of the projects fair share of the realignment of Foster/Turner/Mooney or payment of an in-lieu fee, installation of a stop sign on Foster Drive and Turner Drive, installation of a westbound left turn lane on Foster Drive at Turner Drive, and re striping and re-signing of the Foster Drive and Turner Drive intersection and approaches as needed.
