Project Description (Proposed actions, location, and/or consequences).

Colusa Industrial Properties (Applicant) is proposing a General Plan Amendment and Rezone for properties identified as Assessor \*s Parcel Numbers (APNs): 017-130-107 and 017-030-050 (portion of), located west of Wescott Road, south of Birchwood Place and west of Sunrise Boulevard within the City of Colusa (City), California. Collectively the two parcels represent the project site (Site). In addition, the Applicant is proposing a Tentative Subdivision for the project parcels, in which the Site is proposed to be subdivided into a series of individual lots and land uses.
