

Notice of Intent to Adopt a Mitigated Negative Declaration

State Route 18 Baldwin Lake Pavement Rehabilitation



WHAT'S BEING PLANNED

The California Department of Transportation (Caltrans) proposes to preserve and extend the service life of the existing pavement, as well as other roadway deficiencies along State Route (SR)-18 at Baldwin Lake, from 2.0 miles south of Holcomb Valley Road (Postmile [PM] 56.2) to Camp Rock Road (PM 66.9), in San Bernardino County. The work includes pavement rehabilitation, construction of 8-foot shoulders, replacement of existing signage, upgrade guardrail, remove existing Rock Slope Protection (RSP) and construct concrete channel lining at Cushenbury Creek bridge, construct median and rumble strips, and repair and upgrade culverts within the project limits.

WHY THIS AD?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an *Initial Study (with Proposed Mitigated Negative Declaration)*. This notice is to tell you of the preparation of the *Initial Study (with Proposed Mitigated Negative Declaration)* and of its availability for you to read, and to also offer the opportunity to request a public hearing or to provide comments, and the intent to adopt this Mitigated Negative Declaration.
