**Description of nature and purpose of the Project:** The project proposes a Coastal Development Permit (CDP) to construct a new 2-story, 5,557 square-foot (sf) single family residence and a detached 1,169 sf accessory dwelling unit with an attached 1,195 sf garage and 200 sf bike storage, on a 0.64-acre site. The project site is in the RS-1-4 (Residential Single Unit), within the Peninsula Community Plan, Coastal Overlay Zone (Non Appealable), Coastal Height Limitation Overlay Zone, Parking Impact Overlay Zone (Coastal Impact), Airport Influence Area (San Diego International Airport (SDIA) and NAS North Island, Review Area 2), and the Federal Aviation Administration (FAA) Part 77 Notification area (SDIA). LEGAL DESCRIPTION: Lot 11, Block 2, Tract 979, Warner Villa Tract, APN 532-132-12-00.

Since CEQA Section 15303 allows for the construction of a new residential dwelling unit, this exemption was deemed appropriate. This exemption includes but is not limited to: one single-family residence or a

second dwelling unit in a residential zone. In addition, the exceptions listed in CEQA Section 15300.2 would not apply. The site is not included on any list compiled pursuant to Government Code Section 65962.5 for hazardous waste sites.
