Project Location: The Project is located at 5560 West End Rd, Suite #10, in Humboldt County (APN 507-251-020-000).

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Distributor, Transport Only license submitted on 02/12/2024, by Trim Depot, LLC.

Project Activities:

The Project will consist of Cannabis business operations include transport only distribution. The project is located in a 24,847 square foot building at 5560 West End Rd, Suite #10 in Arcata (APN 507-251-020-000) on a 4.64 acre parcel. The project is located in an Industrial Limited zone (I-L:CIZ, Limited with Cannabis Innovation Zone Combining Zone Area 1). The project site currently operates as a cannabis distribution facility and a processor application is currently pending. Anticipated number of employees are 3-5. Operation hours are Monday-Friday 8AM-5PM. Daily trip generations is 6-10 based on drivers and employees coming to the site. No shipments or deliveries to the project site are contemplated. No expansion of existing structures is proposed.
