F. Reasons why the project is exempt:

On January 4, 2023, Governor Gavin Newsome declared a statewide State of Emergency related to the atmospheric river beginning on December 27, 2022. The storm swell along the coast resulted in damage to the revetment that protected critical infrastructure (a sanitation pump house) along Seacliff beach and deposited several thousand cubic yards of sand onto the established road and parking areas adjacent to the beach. The revetment was bolstered through an emergency coastal development permit that authorized the placement of riprap along the failed revetment. This project is to remove a portion of the sand from the areas immediately east and west of the damaged area and place it on and around the riprap, in order to reestablish use of the beachfront area.
