Description of Nature, Purpose, and Beneficiaries of Project: The proposed project would involve the overhaul of the engine of gas turbine #2 and the upgrade of the turbine and boiler controls at the plant operated by CP Kelco at 2145 Belt Street in the city of San Diego, California. The purpose of the proposed project is to increase reliability, efficiency, reduce nitrogen oxide emissions and to keep power generation running reliably. The work would involve an engine rebuild, new instrumentation, and upgraded fuel delivery equipment.

Construction of the project is anticipated to start in Summer 2024 and would take approximately sixty (60) days to complete. CP Kelco would be responsible for complying with all applicable federal, state, and local laws regarding construction demolition debris, hazards and hazardous materials, and stormwater.

Reason Why Project is Exempt: *The proposed project is determined to be Categorically Exempt pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (Existing Facilities) and Section 15302 (Replacement or Reconstruction) and Section 3.a. and 3.b. of the District's Guidelines for Compliance with CEQA because it is the overhaul of gas turbine #2, fire suppression system, generator and boiler and the upgrade of the turbine and boiler controls at the plant that would: a) involve no expansion of use beyond that previously existing and would not result in a significant cumulative impact due to the continuation of the existing use; and, b) would consist of the replacement/reconstruction of an existing structure/facility, and would be located on the same site as the structure replaced, and would have substantially the same purpose and capacity. Section 3.a and 3.b of the District's CEQA Guidelines are as follows:*

- 3.a. *Existing Facilities (SG § 15301) (Class 1): Includes operation, repair, maintenance, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously existing.*
- 3.b. *Replacement or Reconstruction (SG § 15302) (Class 2): Includes replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site and will have substantially the same purpose and capacity as the structure being replaced.*
