The California Department of Transportation (Caltrans) proposes to replace existing traffic signal heads and existing controller cabinets at various traffic signals on Interstate (I) 205, between post miles 1.39 and 8.12, in San Joaquin County. The scope of work includes the group replacement of traffic signal heads and controller cabinets at the on/off ramps and local street intersection locations. No excavation is anticipated or proposed for this project. All work will occur within Caltrans existing Right of Way. The purpose of the project is to replace existing traffic management equipment that is in poor or outdated condition. This project is needed to keep our existing signals and cabinet controllers at the level of performance required to relay on-time communication to both Caltrans and the traveling public.

#### **General:**

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact the Environmental Office if project changes occur or sensitive resources discovered.

#### **Cultural:**

- If cultural materials are discovered at the job site, do not disturb the resources and immediately:
  1. Stop all work within a 60foot radius of discovery
  2. Protect the discovery area
  3. Notify the Engineer
  4. The Department Investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

#### **Hazardous Waste:**

- 7-1.02K(6)(j)(iii) Unregulated Earth Material Containing Lead
  - Section 7-1.02K(6)(j)(iii) includes specifications for handling, removing, and disposing of unregulated earth material containing lead. Management of this material exposes workers to health hazards that must be addressed in your lead compliance plan. This material contains average lead concentrations below 80 mg/kg total lead and below 5 mg/L soluble lead and is not regulated by DTSC as a hazardous substance or a hazardous waste. This material does not require disposal at a permitted landfill or solid waste disposal facility. The RWQCB has jurisdiction over reuse of this material at locations outside the job site limits.
