The project is located at 8520 Younger Creek Drive, approximately 1,980 feet northeast of the intersection of Florin Perkins Road and Elder Creek Road, in the City of Sacramento.

Description of Project:

The project consists of a Lease Agreement for the relocation of the Sacramento County Department of Child, Family, and Adult Services (DCFA) to an existing 24,000 square-foot office at 8520 Younger Creek Drive. The project does not involve exterior improvements.

Exempt Status:

Categorical Exemption (PRC Section 21084; CEQA Guidelines Sections 15300 -15333):

CEQA Guidelines Section 15301 – Existing Facilities

Reasons why project is exempt:

The project consists of a lease agreement for the relocation of Sacramento County DCFA to an existing office building, involving no expansion of existing use. Therefore, the project is exempt from the provisions of CEQA.

Section 15300.2-Exceptions

Section 15300.2 of the CEQA Guidelines, Exceptions, provides conditions under which categorical exemptions are inapplicable. Review of the Project indicates that it will not violate any of the exceptions, as described in the following section.

- 1. The project will occur in certain specified sensitive environments or locations;
 - The Project site is located within an existing office building in an urbanized city and is not considered biologically sensitive.
- 2. Cumulative impacts will be considerable because successive projects of the same type will occur at the same place over time;
 - The Project will not be expected to result in significant cumulative environmental impacts. The project consists of a lease agreement for the relocation of Sacramento County DCFA to an existing office building. Therefore, no cumulative impacts will result from the Project and successive projects of the same type and at the same place over time.
- 3. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances:
 - There are no known unusual circumstances that will have a significant effect on the environment.
- The project may result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources within a highway officially designated as a scenic highway;
 - The Project is located within an existing office building and is not located in the vicinity of a highway officially designated as a scenic highway; therefore, the project will not result in damage to scenic resources or similar resources within a highway that is officially designated as a scenic highway.
- 5. The project is located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; or
 - The Project site is not included on any list compiled pursuant to Section 65962.5 of the Government Code. Additionally, a search of the EnviroStor and GeoTracker databases was conducted and no hazardous material records were located on site or in close proximity; therefore, the Project will not have an impact related to being located on a hazardous waste site.
- 6. The project may cause a substantial adverse change in the significance of a historic resource.

The project site does not contain any historical resources.
