The proposed project would improve the Idyllwild WWTP to meet existing and future discharge requirements efficiently and consistently for the Idyllwild community. The proposed project consists of the following improvements: Headworks to include new flume and splitter box; additional equalization for heavy precipitation events/two new secondary treatment bioreactors; new sludge holding tank and new sludge handling system; new supervisory control and data acquisition (SCADA) system to integrate controls for plant; new blowers and associated controls in existing blower room; and, new generator and automatic transfer for standby power.
