The proposed project consists of a bus stoarge facility located at the northwestern corner of the existing Sowers Middle school campus and offices, a lounge and restrooms for District staff. The District proposes 15 bus parking stalls, 14 regular parking stalls, one handicapped stall, and an approximately 1,280-square-foot building with offices, lounge and restrooms. The District will operate its routes using 15 buses – five diesel, three gasoline, and seven compressed natural gas (CNG) buses.
