Project Title: EAST OF EDEN CANNABIS COMPANY and FLOR X, INC. (Projects)

Project Location: The Projects are located at 514-516 WORK ST SALINAS, CA 93901, in Monterey County.

#### Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Retailer and Distribution cannabis license submitted on 4/26/2018 and 4/27/2018 by EAST OF EDEN CANNABIS COMPANY and FLOR X, INC.

### Project Activities:

The Projects will utilize an existing 35,800sqft building that previously served as a gymnastics gym and retail store. East of Eden will occupy a 4,137sqft portion of the existing building to operate a store front cannabis retail facility. Flor X, INC will occupy a 7,808sqft portion of the existing building to operate a cannabis distribution facility. Flor X, INC will distribute cannabis, package raw flower, store raw flower and/or manufactured products while they are awaiting testing, and transport cannabis products to licensed retailers.
