The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Mixed-Light Cultivation License. The project would develop up to 10,000 square feet (ft²) of mixed-light cannabis cultivation..

Project Activities:

The Project will consist of construction of a shed, immature plant staging area, and compost area on flat ground. Water for the project would be provided from an onsite well. An onsite septic system would serve the project's wastewater needs. Access to the project site would be via a short driveway that connects to Dirt Road.
