Project Location: The Project is located at 17758 Piper Ln, Penn Valley, CA 95946, in Nevada County.

County: Nevada

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Specialty Outdoor License. The project is located on a rural, 40-acre parcel in an agricultural zoning district. This approval is for 9,993 square feet of canopy consisting of 4998 square feet of outdoor canopy and 4995 square feet of mixed light canopy.

Project Activities:

The Project will consist of 9,993 square feet of canopy. There will be 4998 square feet of outdoor canopy aggregated from eight (8) 6 foot by 100 foot beds and one (1) 6 foot by 33 foot bed and 4995 square feet of mixed light canopy aggregated from three (3) 30 foot by 96 foot agriculturally exempt hoop houses that each contain three (3) 6 foot by 92.5 foot planter boxes. There will be 1,880 square feet of support area consisting of an 8 foot by 10 foot shed for agricultural chemical storage and 1,800 square feet of immature plant area.
