PROJECT DESCRIPTION

The Pinehurst/Miramonte Ingress/Egress Fuel Breaks Project (project) involves the roadside treatment of vegetative fuels along several public road segments in eastern Fresno County, CA. The planned treatment area will extend 30 feet out from both sides of designated roads. The project area encompasses 221 SRA acres, which includes the existing road width, along 19 miles of road. Approximately 135 net acres of roadside vegetation will be treated on the SRA lands.

Vegetation will be treated by a combination of mechanical and manual methods. The primary method will utilize a masticator reaching out from the road's edge. Hand crews using chain saws and pruning saws will be employed as a secondary method. Vegetation targeted for removal will include accumulations of surface fuels, hazard trees, and branches overhanging roads that present a safety issue to the public and emergency personnel.
