**Description of Nature, Purpose, and Beneficiaries of Project:** The proposed project is a Right of Entry License Agreement (ROELA) to the Coronado Cays Homeowners Association (HOA) (Licensee) to enter certain property located in the Coronado Cays, adjacent to the HOA parking lot on Grand Caribe Isle-North, in the City of Coronado, California. The area proposed for use under this ROELA would be used by the Licensee and its authorized agent(s) and contractor(s) exclusively for the purpose of landscaping, provided, however, that no activities or improvements of the Tenant shall interfere with the use and enjoyment of the premises by the general public and for no other purpose whatsoever without the prior written consent of the Executive Director of District in each instance. No increase in the size of the area is proposed or authorized as part of the ROELA.

It is anticipated that the ROELA would have a total term of approximately 5 years. The ROELA may be terminated by the District as a matter of right or without cause at any time upon providing twenty-four (24) hours written notice to Licensee of such termination.


