The project proposes to demolish the existing 20 foot tall former SkyPark long-term airport parking facility (approximately 219,565 square feet) and associated surface parking lot in order to construct a 97,464 square foot warehouse, including 9,510 square feet of interior office space, with rooftop parking and ancillary site improvements. The warehouse would be approximately 50 feet in height. The building would also include an approximately 40,105 square foot covered van staging area. The majority of the project would occur within the City of San Bruno. Within the City of South San Francisco, a new drive aisle would be constructed to provide access to San Mateo Avenue.
