Section 15300 through 15333 of the California Environmental Quality Act (CEQA) establishes certain classes of projects as categorically exempt from the provisions of CEQA because they do not ordinarily result in a significant effect on the environment.

Lead Agency: City of Long Beach Community Development Department.

Applicant Entity/Business Name: Green Ace LLC.

License Type(s): Business Licenses for an Adult & Medical Use Cannabis Cultivation Facility.

Project Description:

The project is located at 1545 Cowles St, Long Beach, CA 90813 within Los Angeles County (Figure 1 – Vicinity & Aerial Map). The site is on the north side of Cowles Street and to the east of the nearest intersection, Cowles Street and Canal Avenue. The site Assessor's Parcel Number, 7432-012-025, and features an area of 0.23-acres.

The 0.23-acre subject site and surrounding properties are located on relatively flat lots. There are no natural features in the immediate, or quarter-mile vicinity.

The subject site is within the General Industrial zoning district (IG) and has a General Plan Land Use PlaceType designation of Industrial (I- 65 ft).

The subject site is currently developed with a 9,600 square-foot industrial building, 18'-0" in height. The proposed Adult & Medical Use Cannabis Cultivation Facility would utilize the entire 9,600 square-feet within the building. The site features no curb cuts. Vehicular access to the site is limited to an existing rear parking lot off the alley, or street parking. The property is located within an AB2097 area, and the City cannot require any additional parking.

The project proposes minor interior improvements to the industrial unit. Interior improvements include adding new partition walls, new finishes and associated plumbing, mechanical, and electrical upgrades.

The project has obtained city approved permits which include a building permit, health permits, and business licenses.

The primary operations will occur entirely within the enclosed structures and pose limited potential for environmental impacts on neighboring uses. All medical and adult use cannabis facilities are subject to stringent rules and regulations governed by Long Beach Municipal Code Title 5 – Regulation of Businesses, Trades, and Professions.

1. Is the project site currently operating as a cannabis cultivation site or a similar use, or has it recently operated for this purpose?

The site was formerly utilized as a bearing manufacturer. The site is within the General Industrial zone that is served with existing public infrastructure which includes sewer, water, electrical and gas services. The previous use in the industrial building dates to 1990 and was licensed until 02/01/2009. The proposed adult & medical use cannabis cultivation facility is identified as an industrial use by the Long Beach Municipal Code.

2 Does the project involve an expansion of existing structures that would be considered only minor?

The existing 9,600 square-foot industrial unit footprint will not be expanded. Minor improvements proposed include interior and exterior alterations, plumbing, electrical, mechanical, and similar typical tenant improvements.

3. Project Expansion:

This question is not applicable as this project consists of only interior and exterior tenant improvements to an existing 9,600 square-foot industrial building. No expansion is proposed.

4. Is the project site served by all public services sufficient to serve the project (e.g., water, sewer, electricity, and gas)? The preparer should indicate which public services serve the site.

The project site is currently served by all city public services which include sewer, water, and gas infrastructure as confirmed by the current internal GIS city-data accessed on May 29, 2024. The site is also serviced by Southern California Edison (SCE) for electrical needs as confirmed by SCE's service territory map, accessed May 29, 2024. 5. Is there evidence that the project site is located in an environmentally sensitive area?

This project is not located in an environmentally sensitive area as verified on the GeoTracker website on May 29, 2024. 10. Is there evidence of the potential for the project to contribute to a significant cumulative impact?

This project proposes to reuse an existing 9,600 square-foot industrial unit for an adult & medical use cannabis cultivation facility. The operations of this facility do not provide evidence of the potential for the project to contribute to a significant cumulative impact as the use is in an Industrial zoning district which allows industrial type uses. The proposed project as an industrial use is anticipated by the City of Long Beach General Plan and Land Use Element and would not contribute to a significant cumulative impact that was not previously analyzed. The Long Beach General Plan Program Environmental Impact Report (PEIR) was adopted in December of 2019 (State Clearinghouse No. 2015051054). The project's impacts are furthermore mitigated by conditioned compliance with applicable code requirements which include, but not limited to, noise, discharges, and material handling.

11. Is there evidence of a reasonable possibility of a significant environmental impact due to unusual circumstances?

The project does not contain any unusual aspects in the ongoing operations that may lead to a more substantial impact. The proposed use is consistent with industrial uses allowed in the zoning district.

Eligibility Determination

Based on information contained in the administrative record, as reflected in the answers provided to Questions 1-11 above, the project or project element(s) are eligible for a Class 1 categorical exemption. The project or project element(s) fit(s) within the parameters included in CEQA Guidelines Section 15301, and none of the exceptions to this exemption defined in Section 15300.2 apply.
