Project Title: Sierra Select Gardens (Project)

Project Location: The Project is located at 14887 Gearhart Ranch Drive in Nevada County.

County: Nevada County

Project Description: The Department of Cannabis pursuant to authority granted under Business and Professions Code Division 10, Chapter 2, Section 26012, approved a small outdoor commercial cannabis license.

Project Activities: The Project will consist of an Administrative Development Permit for the cultivation of cannabis located on a rural, 101.93-acre parcel in an Agricultural zoning district. This approval is for 8,000 square feet of outdoor cultivation and 1,700 square feet of mixed light canopy area within an agriculturally exempt hoop house for a total of 9,700 square feet of canopy area. The project will include 7,024 square feet of support area located within five (5) agriculturally exempt hoop houses for immature plants, an 800 square foot commercial building for harvest storage, trimming and immature plant area and a 144 square foot shed for self-distribution.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. On May 14, 2019, Nevada County Resolution No. 19-199 certified a Program Environmental Impact Report (PEIR; SCH #2018082023) for the Nevada County Commercial Cannabis Cultivation Ordinance. On January 10, 2023, the Nevada County Board of Supervisors adopted an Addendum to the certified PEIR which analyzed potential impacts associated with amendments to the Nevada County Commercial Cannabis Cultivation Ordinance. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
