Caltrans proposes a HM1 routine maintenance project in Imperial County about 26 miles east of Holtville from 1.0 mile east of Gordons Well overcrossing to 0.6 mile west of Ogilby Road overcrossing. The work will be maintaining the AC pavement life by cold planing and applying RHMA-G overlay and overlay from edge of pavement to edge of pavement on both directions. In addition, roadway signs and posts will be replaced at identified locations. All work will be within the State ROW and the existing pavement limits, except for some routine shoulder backing (0'-3' from edge of pavement) as needed at various identified locations, fog sealing or replacing of the existing AC dikes. Environmental Commitments are included in the ECR.
