Description of Nature, Purpose and Beneficiaries of Project:		
The purpose of the project is to replace a water system that has reached the end of its service life, which will improve water service flows, improve customer water quality, improve fire protection, reduce water losses from leaks, and minimize the need for future maintenance. The project would replace 6,400 linear feet of water main serving 65 low-income households, as well as replace the Edgehill Booster Station. The project would also include the installation of new fire hydrants approximately every 300 feet within the project site. New hydrants are needed because there are an inadequate number of fire hydrants in the overall area, and fire flows are either		
non-existent or are extremely low. The addition of new hydrants will bring fire flows into compliance with minimum standards of 1,000 gallons per minute.
