Project Title: Streambed Alteration Agreement No. EPIMS-CAL-46738 (Pumpkin Spice Timber Harvesting Plan 4-23-00131-CAL, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in Calaveras County, within CALWATER watershed Upper Blue Creek and its connecting tributaries; Township 7N, Range 16E, Sections 21-23 and 26-28, U.S. Geological Survey (USGS) Quad Maps Calaveras Dome; Mount Diablo Base and Meridian

Project: The four projects are limited to water drafting, replacement of an undersized culvert, and installation of a temporary vented ford or modified Spittler. Further explanation of work can be referenced within the THP 4-23-00131-CAL.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
