Project Title: Green Birds, LLC (Project)

Project Location: The Project is located at 2300 Curry Street (APN 7119-017-006) in the City of Long Beach, Los Angeles County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Specialty Indoor license submitted on 06/29/2022, by Green Birds, LLC.

Project Activities:

The project consists of the establishment of a cannabis cultivation facility within an existing 36,395 square foot (sf) building located at 2300 Curry Street (APN 7119-017-006) in the city of Long Beach. The project proposes the cultivation of 5000sf of mature cannabis canopy, 1440 sf of immature plant canopy and associated support operations. The building footprint will not be expanded. Construction will be limited to interior tenant improvements and a façade remodel.
