Project Title: Jack Rabbit Farm (Project)

Project Location: The Project is located at **90 Drinkwater Gulch (APN 016-210-09-00) near Hayfork in Trinity County.**

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Specialty Outdoor commercial cannabis license.

Project Activities: The Project will consist of an existing cannabis cultivation operation located at 90 Drinkwater Gulch (APN 016-210-09-00) near Hayfork in Trinity County. The project is on a 4-acre parcel zoned as Agriculture. An existing +/-5000 square foot (sf) cultivation area and two (2) 120-sf greenhouses for immature plants are found on the parcel. Additional existing facilities include a 3,500 sf barn, a 36 sf shed and a 300 sf building for storage, a 120 sf shed for processing, a 153.5 sf compost area and water storage tanks. Water for this project is provided by an existing groundwater well.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
