Project Title: Barker Creek Farm LLC (Project)

Project Location: The Project is located at 1735 Barker Creek Rd., Hayfork, CA 96041 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project includes the continued cultivation of 10,000 square feet (sf) of existing small mixed light tier 1 cannabis consisting of 7,000 sf of permitted greenhouses and 3,000 sf of outdoor light deprivation cultivation and continued utilizing 1,480 sf of support infrastructure consisting of two buildings. An existing well is used to supply water and an onsite septic system would serve the project's wastewater needs. Energy is provided by the Trinity Public Utilities District. Access to the project site would be via a private driveway off of Braker Creek Rd.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
