Project Title: Browns Mountain Farms, Inc (Project)

Project Location: The Project is located at 880 Elderberry Lane, Weaverville, CA 96093 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project includes the continued cannabis cultivation of 8,960 square feet (sf) of mature cultivation consisting of two (2) 30'x96' greenhouses, one (1) 20'x100' greenhouses and one (1) 60'x20' greenhouse and 1,200 sf of immature cultivation consisting of one (1) 20'x60' greenhouse and continued utilizing 1,390 sf of support facilities. A permitted well and a pump are used to supply water and a permitted septic system would serve the project needs.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
