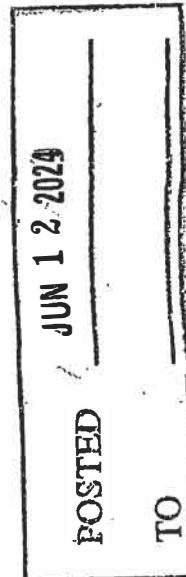

Project Description

The San Francisco Municipal Transportation Agency (SFMTA) proposes the Fell Street Class IV Bikeway project to make permanent the changes that were temporarily implemented as part of the Panhandle Social Distancing and Safety Project (San Francisco Planning Case No. 2020-006678ENV), in July 2020. The project would establish a permanent westbound parking protected Class IV bikeway on Fell Street between Baker and Shrader streets by reducing Fell Street from four lanes to three lanes. The south side

parking lane would be converted into a bike lane and one through lane would be converted into a floating parking lane.

Determination

The City and County of San Francisco decided to carry out or approve the project on June 20, 2023, when the SFMTA Board of Directors approved the project. The project was officially approved on July 21, 2023, when no appeal of the statutory exemption was filed during the 30-day appeal period. Specifically, the SFMTA (a public agency) proposes the permanent implementation of bicycle facilities within San Francisco for a cost of less than \$50,000,000.


