The applicant seeks approval of Vesting Tentative Map for a 33 parcel townhome project. One exception to Code Section 914-12.002 which requires detention basins to be at least 15-acre-feet of storage volume is included to allow small detention basins that are privately maintained and funded. Multiple variances to the setback, height and lot coverage maximum are being requested. A tree permit for the removal of 5 trees and work within the dripline of 9 others and grading of 10,200 cubic yards is also included.
