Project Title: Buck Mountain Cannabis (Project)

Project Location: The Project is located at 20800 Banner Quaker Hill Rd., CA 95959 in Nevada County.

County: Nevada County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 2 commercial cannabis license.

Project Activities: The Project includes 9,996 square feet of outdoor cannabis canopy and 3,172 square feet of support area. The Project is located on a rural 27.57-acre parcel in a Forest zoning district. The support area includes a 2,916 square foot easy-up canopy for packing, processing, and curing area, a 160 square foot agriculturally exempt shipping container for chemical/pesticide storage and administrative hold, and a 96 square foot material storage shed. Water for the project is provided from an existing well. An on-site septic system is used for sewage disposal.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. On May 14, 2019, Nevada County Resolution No. 19-199 certified a Program Environmental Impact Report (PEIR; SCH #2018082023) for the Nevada County Commercial Cannabis Cultivation Ordinance. On January 10, 2023, the Nevada County Board of Supervisors adopted an Addendum to the certified PEIR which analyzed potential impacts associated with amendments to the Nevada County Commercial Cannabis Cultivation Ordinance. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
