A major focus of this update was to clarify and enhance the ALUCP policies to improve local implementation of the plan by local jurisdictions. Updating the ALUCP to reflect the fact that Calistoga Glider port is no longer in operation and all references removed from the Plan. The end goal of the ALUCP update is to employ a transparent decision-making process that results in community-wide acceptance of the ALUCP and adoption by the ALUC. The goal of the process is adopt the updated Napa County ALUCP and the associated Initial Study Negative Declaration finding that the update will not result in any significant impacts.
