The applicant seeks approval of a Standard Coastal Development Permit to grade a driveway to the west of Nonella Lane, construct a 2,366 square-foot three-bedroom single-family residence, a 1,016 square-foot detached garage/workshop, construct a PG&E transformer pad, extend underground utilities 500 feet from pad to building site, install a septic system, water tank, pumphouse, and convert a test well to a production well.
