The proposed project site is located on Butte Slough adjacent to its confluence with the Sacramento River. The project site is located approximately 5 miles downstream from the town of Colusa in both Sutter and Colusa counties and is accessed by Marty Road on the Sutter County side and Butte Slough Road on the Colusa County side. The proposed repair project consists of several maintenance repairs include installing supplemental outlet headwall support, replacing the existing inlet catwalk, repairing the inlet slide gates, installing a new facility control building, and installing water flow/condition monitoring equipment. These maintenance repairs would address both short-term flood safety goals by providing safer and more reliable gate operations but would also contribute to the longer-term objective of extending the functional life of the Butte Slough Outfall Gates (BSOG) facility to ensure it continues to be operated to reduce flood risk.
