The Brannan-Andrus Levee Maintenance District (BALMD) is proposing the Georgiana Slough Erosion Control and Habitat Enhancement Project to resolve upper slope erosion problems and a major lower slope undercutting issue along the right bank levee of Georgiana Slough, on Lower Andrus Island. The Proposed Project would involve construction of proven erosion control methods involving placement of quarry stone rip rap (or rock slope protection - RSP) at the toe of the levee,
