Project Title: Barker Valley Agro LLC (Project)

Project Location: The Project is located at 241 North Meadow Lane, Hayfork, CA 96041 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project is both proposed and existing in nature. The existing project consists of an ongoing cannabis cultivation operation. The site comprises three (3) permitted greenhouses 30'x72' (canopy is 25'x72') for mature cultivation and two (2) temporary hoopouses 20'x100' for mature cultivation, totaling 9,400 square feet and two (2) temporary hoopouses 30x100' for immature cultivation, totaling 6,000 square feet. Proposed infrastructure includes the conversion of two (2) temporary hoopouses to permitted greenhouses for mature growth and the conversion of two (2) temporary hoopouses to permitted greenhouses for immature growth. A permitted groundwater well on the adjacent property under the same ownership is used to supply water and a permitted septic system would serve the project wastewater needs.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
