Project Location: The Project is located at 300 Pioneer Street, Santa Cruz in Santa Cruz County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution License submitted on 04/28/2019 by William Sump.

Project Activities:

The Project will consist of a cannabis distribution and manufacturing facility located at 300 Pioneer Street, Santa Cruz, CA 95060. The APN is 001-172-18. It will operate out of an existing building on a lot area of 4.06 acre. There are four buildings on site, including a 39,268 SF multi-tenant building, a 2292 SF building that includes Moriarty's Roofing, a 4968 SF commercial building, and the subject 1200 SF commercial building. The interior space will have room separations for non-volatile manufacturing, distribution, and office space.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
